- Eligibility for Dengie Winter League Open to individual Pony Club Members, but excluding any combination of horse/pony and rider that have represented their Branch at OPEN Area qualifiers for The Pony Club Show Jumping Championships or any rider who has competed at The Pony Club Open Show Jumping Championships or The Pony Club Show Jumping Final at Hickstead. (This does not include any other classes held in conjunction with Area Qualifiers.
- 2. The competition will be judged under P.C Show Jumping Rules (2010) and the judge's decision is final.
- 3. Team members will also be judged as individuals
- 4. Teams to consist of 3 or 4 riders, best 3 scores count
- 5. Teams will jump en bloc in drawn order
- 6. No spurs may be worn in classes 1 and 2 or in other classes by members who have not passed their B test, without their spurs cards signed by their D.C
- 7. Jackets and ties or stocks must be worn and hair must either be above the collar or securely tied back and contained in a hair net.

Inter-Branch Winter League. A shield will be awarded to the branch that accumulates the most points.
